The British Columbia (BC) government withheld a number of public documents by Imperial Metals Corporation / Mount Polley Mining Corporation following the Mt. Polley mining disaster of August 4, 2014. In fact, many of these documents (as a conditional requirement under two Ministerial permits) were never forwarded to public libraries by MPMC when they were published and forwarded to the BC government since the late 1990s. These concerns were noted in news media articles, and in the B.C. Tap Water Alliance's December 1, 2014 report, [The Scene of the Crime: A Preliminary Analysis of the Mount Polley Mine's Tailings Storage Facility](#).

Many of these withheld documents were finally released by the BC government on January 30, 2015 (see website link above) to accompany the findings of the panel member review of the Mount Polley mining disaster.

Only the previously withheld Annual Environmental and Reclamation reports and the annual Tailings Storage Facility (TSF) inspection reports conducted for the Mount Polley mine are provided here as references for easy public review and access (see Table 2-1 below, and refer to the Document ID in order to find the location and link for the document found in the website source reference above).

However, **some of the content material in the Annual Environmental and Reclamation reports for 1999-2008 is still being withheld**, i.e., title pages, appendixes, maps, tables, figures. **The public awaits the release of these missing report segments.**
