McNeill Lake is called Haslam Creek in this list, and is found on pdf page 52, as a Category 2 Reserve. In actuality, this Reserve boundary was made for two adjoining watersheds, the Haslam (north) and Silversands (south) watersheds.



This list of Watershed Reserves is in a document called Appendix G, and was attached to a Ministry of Environment document published in October 1980, Guidelines for Watershed Management of Crown Lands used as Community Water Supplies. Though this 1980 document never made reference to how government had created (and re-created) Watershed Reserves, the first draft document written in 1977 did, and those references were later deleted before the final document was published.

The 1980 Guidelines document also included a set of provincial maps identifying the boundaries, locations and numbers of the Watershed Reserves within various administrative provincial Water Districts. Table columns on the maps provided the data for each water source.

Cautionary Note

During tabulation of the data, certain inexactitudes have had to be tolerated with respect to allocation of populations served by the individual watersheds. For example, certain communities are served by more than one source, the proportion per source not being known; some of these sources may only be used on an intermittent basis, depending upon needs. A few sources are used solely for standby purposes.

For the purposes of the computer print-out, it was necessary to allocate a population figure to each watershed. In most cases the figures were simply pro-rated to the respective sizes of the watersheds serving a single community. In others, a best estimate was made by seeking information from those familiar with a particular operation.

Fortunately, the approximations apply only to a small proportion of the watersheds, thus the collective data can be assumed to agree reasonably closely with the general picture, while not always in accord in specific cases.

As the number and status of watersheds in the program are subject to constant change, this listing will seldom be up-to-date. From time to time, the amendments will be processed and a new listing issued.
